

## Advanced Emergency Medical Technician Program and degree information

Upon successful completion, the candidate is eligible to receive a Technical Certificate and challenge the National Registry exam to obtain National Certification as an Advanced Emergency Medical Technician and apply for a Tennessee State license as an AEMT. Information is available from the Tennessee Department of Health, Emergency Medical Services Board. Initial AEMT License Requirements in TN are available online.

Students pursuing this program who live outside of Tennessee or plan to move to another state are warned there may be additional requirements needed to obtain licensure or certification in another state. Some states did not currently identify Advanced EMT as a licensure level at this time of this review and are shown Not Available. Consult the appropriate state licensing/certification board to determine if the chosen program of study will meet the requirements in the state(s) where you intend to seek employment. Columbia State has not determined if requirements are met for licensure in all states or territories of the United States. Even if identified in the table below as Meets, it is possible requirements have changed since last reviewed.
