The program is accredited by the American Veterinary Medical Association. Upon successful completion of the program students are awarded the Associate of Applied Science degree, are eligible for the Veterinary Technician National Exam (VTNE) administered by the American Association of Veterinary State Boards (AAVSB), and to apply for licensure by the State Board of Veterinary Medical Examiners as a Licensed Veterinary Medical Technician (LVMT) in Tennessee. The Tennessee Department of Health, Board of Veterinary Medical Examiners provides online information for application and licensure for Veterinary Medical Technicians.

Students pursuing this program who live outside of Tennessee or plan to move to another state are warned there may be additional requirements needed to obtain licensure or certification in another state. Consult the appropriate state licensing/certification board to determine if the chosen program of study will meet the requirements in the state(s) where you intend to seek employment. Columbia State has not determined if requirements are met for licensure in all states or territories of the United States. Even if identified in the table below as Meets, it is possible requirements have changed since last reviewed. Contact the appropriate licensing board in the state where you intend to seek licensure regarding the requirements in that state.
